2. E OVIEDO01: The receiving institution will send its decision within 3 weeks.

CH ZURICH01: The University of Zurich will normally send its decision within 4 weeks. However, some subject areas may need more time for the decision.

3. E OVIEDO01: A Transcript of Records will be issued by the receiving institution no later than 12 weeks after the assessment period has finished at the receiving HEI.

CH ZURICH01: A Transcript of Records will be issued by the first week of the semester following the exchange period (the autumn semester starts in week 38, the spring semester in week 8).

4. Termination of the agreement

This Collaboration Agreement may be terminated on the following grounds:

- End of the stipulated period of validity.
- Mutual agreement between the parties.
- Written notice of termination with 6 months in advance, provided the termination shall not become effective until the end of the stay of the students enrolled in both institutions on the date of notification.


